Below is a brief description of the positions that need to be filled for the 2019-2021 term. A complete description of the Duties of Officers is located in the 2018-2019 Yearbook on pages 179-180.

Second Vice President – This officer chairs the Program Committee and shall have responsibility for securing programs for the 2020-2021 club year.

Third Vice President – This officer serves as Membership Chairman, checking all new applications and notifying new members and their sponsors of their election to The Club. She works with the office to manage membership updates and status changes and keeps the Board informed of membership changes. This officer also supports the chairmen of the new member orientation and new member project.

Recording Secretary – This officer keeps an accurate record of the proceedings of all business meetings of The Club and the Board of Governors and is responsible for communicating motions that passed at board meetings to the office.

Assistant Treasurer – This officer assists the Treasurer in maintaining the financial records of The Club and assumes the position of Treasurer the following year.

Activities Committee (2) – There are two positions to be filled which interact with the two current activities chairmen to plan day trips, classes, Brown Bag Luncheons, as well as arrange overnight trips. These positions require extensive organization and dedication.

Finance Committee – This member-at-large along with the current chairman is responsible for club facility rentals, philanthropy, overseeing budget formulation, and all other financial matters for The Club.

House Committee – This position is responsible for ensuring that the club facility is clean, attractive, in good repair and running smoothly.

Information Committee – In the first year, this position is responsible for editing the content of the weekly *Tuckahoe Flyer* and in the second year, the content, publishing and distribution of the annual Yearbook, as well as becoming the Bylaws and Standing Rules Chairman.

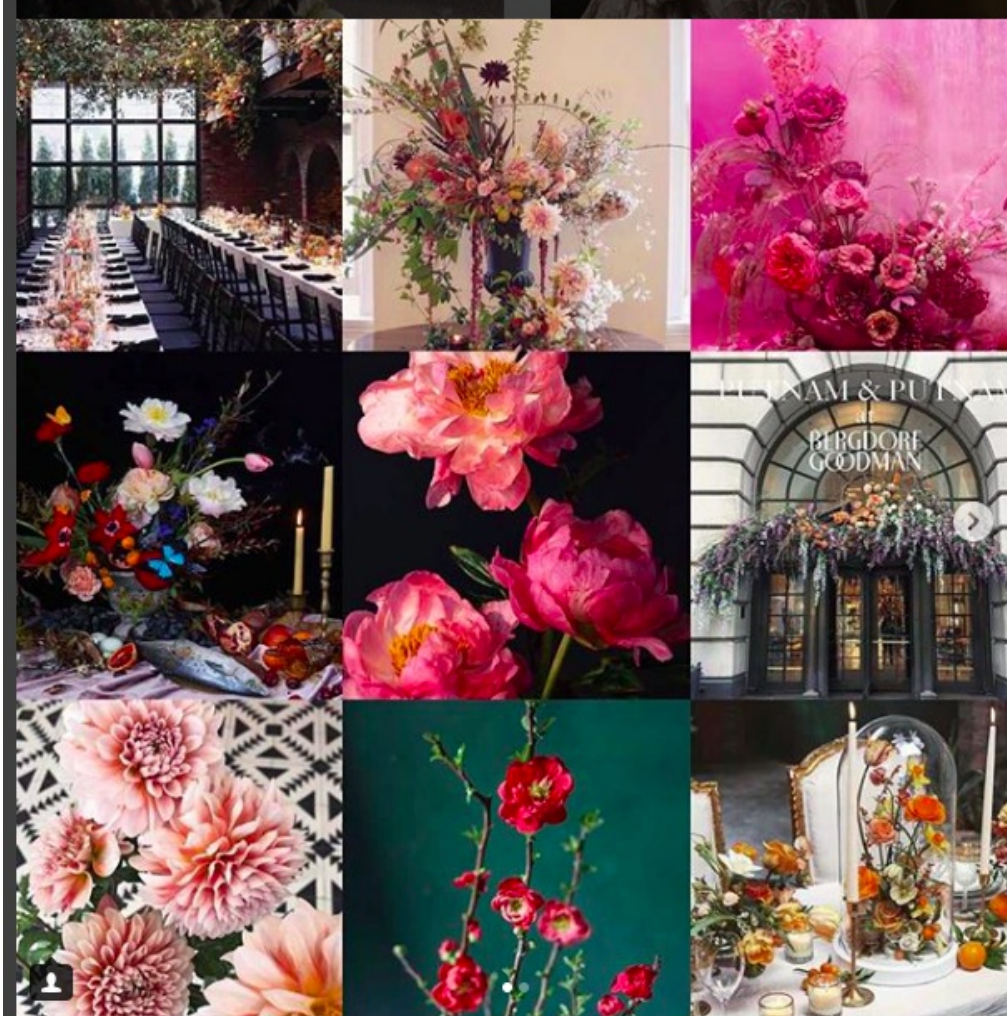
Our goal is to collect enough food and funds so that The Club can provide a minimum of 3,000 meals.
